Note:

The term of a standard patent is up to a maximum of 20 years from the deemed date of filing of the patent application. The proprietor shall pay the prescribed renewal fees in accordance with the Patents Ordinance and the Patents (General) Rules to keep the patent in force. Fees should be accompanied by the specified patent renewal form.

《專利條例》第 39(2)條規定，須以專利的當作提交日期在批予專利後第一個周年日起計，在第 3 年或繼後任何一年(視屬何情況而定)屆滿前，繳付續期費再維持專利有效一年，但不得早於屆滿日期 3 個月前繳付。

Under section 39(2) of the Patents Ordinance, to keep the patent in force for a further year after the expiry of the 3rd or any succeeding year from the anniversary of the deemed date of filing of the standard patent first occurring after the date of grant, the renewal fee shall be paid before the expiry of that 3rd or, as the case may be, succeeding year but not earlier than a date 3 months before that expiry.

如專利註冊處在上述期限內沒有收到有關表格及續期費，則在期限屆滿後 6 個月內繳付的續期費，必須連同訂明的逾期附加費一併繳交。如專利註冊處未能在訂明期限內收到有關費用，專利便會停止有效。If the form and fee are not lodged with the Patents Registry within the above-mentioned period, any renewal fee paid within the period of 6 months after the end of that expiry shall be accompanied by the prescribed additional fee for late payment. If no fee is received within the prescribed period, the patent will cease to have effect.
